Old Business

New Business

AAAE Response to Council 10X15. Jacque Deeds moved, Duncan seconded the motion that AAAE endorse and commit to the 10X15 goal. There was no discussion; motion passed.

Agricultural Education Opportunity Fund – T. Hoover moved, Osborne seconded the motion that AAAE donate \$3000 to the Ag Ed Opportunity fund. Motion passed by majority vote.

Western Region proposal to move the annual AAAE Conference to the week prior to The National FFA Convention in Indianapolis, IN starting in 2009. The motion was moved and seconded, and Jack Elliot presented it to the membership. Both support and opposition was expressed among the members. Question was called from the floor and a vote was taken. Motion failed by voice vote.

Travis Park moved that the membership create a new meeting to be held during the AAAE Conference for Assistant Professors who are on the Promotion and Tenure track. Park asked the AAAE President to consider placing this meeting on the agenda for the 2007 AAAE Conference and that the Association allocate \$500 to support this proposal. The motion was seconded and passed by majority vote.

Jim Conners moved to remove from the table the motion regarding multiple publications that was presented at the 5.18.06 business meeting; motion was seconded. He discussed the "yellow" document shared by Rama (JAE Board) and the proposal that only abstracts be printed in the conference proceedings for future AAAE conferences. Motion was seconded; failed by voice vote.
