## July 2007 Meeting:

The Board adopted a motion to identify the following *Research Priority Areas* and *Key Research Questions* from the National Research Agenda – Agricultural Education and Communication as priorities to the National FFA Organization:

## Agricultural Leadership

RPA 1: Develop and disseminate effective leadership education programs.

• How can leadership education programs be designed and implemented to increase the leadership capacity of youth, communities, higher education, agribusiness and allied organizations in domestic and international settings?

RPA 2: Support leadership opportunities for underrepresented populations.

• How will the inclusion of underrepresented populations enhance leadership capacity in youth, communicates, higher education, agribusiness and allied organizations in domestic and international settings?

## Agricultural Education in Schools

RPA 1: Enhance program delivery models for agricultural education.

- What types of program delivery models best respond to the changing population?
- How do agricultural education program delivery models enhance food, fiber and natural resource systems?
- How do the components of an agricultural education program influence student success and overall program quality?

RPA 5: Determine the effects of agricultural education instruction.

- How does student participation in agricultural education programs contribute to premier leadership, personal growth, and career success?
- How do agricultural education programs contribute to student achievement and performance?
- How do quality agricultural education programs contribute to school and community vitality?

Adopted a revised MOU with the Department of Education. The updated memorandum will stipulate that one of the four Board positions is to be filled by a representative of the agriculture industry, and it will reduce the number of agriculture teacher-filled positions from two to one. It will also remove regional rotation as a requirement for NAAE nominees. A related motion passed to add an additional consultant from the NAAE.

Adopted a motion to provide a training experience for the national officers after their year of service that would continue to develop their potential for success by helping each past officer create a plan for continued development and transition back into life after the year of service as a national officer.

## **January 2008 Meeting:**

Approved a motion to name the cities of Indianapolis and Louisville as finalist cities for the National FFA Convention for the years 2013-2019.

Approved a motion to recommend that student delegates in October, 2008 set member dues a \$7.00 for 2009-10.

Approved motions related to American Degree requirements to be sent to 2008 Convention delegates with a recommended implementation date of 2011:

- o Add the words "after entering agricultural education" to indicate a student must demonstrate program growth during the years involved in agricultural education.
- o Raise the student required SAE earnings to \$10,000.

- o Leave student required SAE productive investment at \$7,500.
- o Raise the minimum required productive investment when using unpaid hours to \$2,000.
- O Change unpaid hours formulation to (Unpaid Hours X 3.56) + (Actual dollars productively invested) must be >/= 10,000.
- o Add community involvement requirement recommendations to all degrees:
  - Chapter degree recipients should participate in at least 10 unduplicated hours of community service activities.
  - State degree recipients should participate in at least 25 unduplicated hours of community service within at least two different community service activities.
  - American degree recipients should participate in at least 50 unduplicated hours of community service within at least three different community service activities.

Approved a MOU between the National FFA Organization and The Consortium of Collegiate Agriculture Organizations for funding and management of a 1.0 FTE Education Specialist housed in the Collegiate Services Team to work collaboratively with the 16 organizations making up the Consortium.

Approved motions recommending the National FFA Board of Directors establish a national taskforce charged with the creation of an age appropriate, novice parliamentary procedure event and an age-appropriate Agricultural Education General Knowledge CDE for 7<sup>th</sup>, 8<sup>th</sup> and 9<sup>th</sup> grade FFA members to be held at the National Convention.

Approved a motion to accept the guidelines for National Awards and Recognition Revision process which will:

- Identify and align Agriculture Food and Natural Resources content standards and related academic content standards with all applicable initiatives.
- Use quality program standards to guide all applicable initiatives (IE: National Chapter Award, SAE Awards).
- Provide opportunity to earn available or potential industry credentials.
- Assure that business and industry partners play a significant role in the development of related technical content in all initiatives.
- Establish and recognize levels of mastery related to all initiatives.
- Establish rigor based on academic content and curriculum content standards.
- Incorporate recommendations from major taskforce reports (Middle School, Hispanic Engagement, Diversity and Collegiate) into the revision process.
- Expand current award opportunities for students with Exploratory, Research, Placement, or Entrepreneurship SAE Programs.
