Plans are moving forward for the May 2019 conference in Des Moines. There will be some changes to the agenda based on feedback.

Oklahoma State will host the 2020 national conference, and planning is in progress.

At the last national meeting, there was a motion for a AAAE Leadership Academy. Ed Osborn, Florida, is drafting the agenda and has requested for a day prior to the national meeting for the leadership academy. There will be an application process. Details are not fully available.

Dr. Torres attended the National Council for Agricultural Education meeting. The council is at a point where they feel like they need to dispand or re-invent itself with stronger leadership and a unified voice. The council has been around since the mid 1980s. The national summit will bring forward some ideas for the council.

## VI. Identify new business items

a. Awards - Align with National - Lori Moore

Western Region's awards are out of alignment when compared to AAAE. Both groups offer Distinguished Teacher, Distinguished Researcher, Outstanding Ag Educator, and Outstanding Early Career Awards. Western awards an Outstanding International Ag Educator and national does not. Dr. Moore asked if we wanted to offer the same awards as national. However, rarely does the region award all five categories.

Carl Igo moved to add the national awards and keep the International Ag Educator award.

Kasee Smith said the overall research submissions decreased. There were 43 manuscripts sent to reviewers. This is down from 55 in 2017. Molly Aschenbrenner, Becky Lawver, Shannon Arnold, Rob Terry, and Courtney Meyers served on the panel and were acknowledged for their service.

## VIII. Poster Session Report – Theresa Murphrey

Theresa Murphrey said the poster abstract submission system remains the same. There were 61 abstracts submitted: 17 innovative and 41 research. The reviewers accepted 12



innovative and 28 research posters. Posters were accepted based on those that had two reviewers that supported the poster.

#### Minutes:

- One of the concerns at the national level in the member services committee was how to get members more involved, especially as it relates to reviewing journal articles. Two of the members on the regional committee have not reviewed an article in a year or two because they have not received an article to review. This could be an issue on the system side or the individual side. So, we recommend that we look into this issue more to see if there is a missing step or link that is causing faculty to not receive articles to review.
- We also recognize that reviewing is hard in terms of time and effort. Therefore, we recommend
  that faculty have the opportunity to nominate masters students to review posters at the
  regional level. If faculty have an outstanding masters student that they believe has the research
  experience to review poster abstracts, we believe those students should have the opportunity
  to experience the review process.
- We brainstormed ways that we could increase attendance at the regional meetings. One way we discussed it incorporating an opportunity to form collaborations—much like an intellectual synergy. We recommend this replaces one of the committee meetings and that it occur in the middle of the conference and not tacked on to the front or the back. We also discussed creating an opportunity for graduate students to ask senior faculty members questions in a roundtable format. Each table has a faculty member and a topic, and graduate students can go to the table and ask questions. Examples of topics would be mentoring graduate students, grants, promotion and tenure, etc. We recommend the hosts in the coming years consider this type of activity.



• If we want an increase in attendance, we may want to consider alternative ways of doing things.

To make solid recommendations, we would need more data.

#### Minutes:

The meeting began with introductions and Shannon explaining te roles of the committee.

Discussion of the Early Career and graduate student breakfast/reception was held. The suggestion made to National AAAE is to consider an evening event instead of a morning event and consider the set-up of the room (should promote interaction)/

Also suggest considering the time of Barrick Seminar and Knapp Seminar. When scheduled at a meal time (and meal not provided) or close to meal time then less people tend to attend the event.

Dr. Ramsey brought up the idea of having a list of "experts" or people who would feel willing to talk to others about certain topics available on the website.



Dr. Arnold brought up the idea of rotating through early career, mid career, and late career topics of interest.

The is was discussed to have everyone in the room at the same time by be seated at tables by years of experience at each table to facilitate discussion relevant to each group.

Discussing the student scholarship took the majority of our time.

We recommend that the scholarship be called an award and that it be advertised with the other awards but an additional announcement about the award should be sent out by the chair or communications person. The due date should be July 1 and the committee should try to make selections by August 1<sup>st</sup>. The students should be notified about the award then as that may impact their decision to attend. The committee recommends this be an award that is not tied to the amount of the registration fee and that we delete any language of registration fees from the application. Instead we recommend the award be set at \$250 and the committee will decide on the number awarded based on the funds available for the scholarship award.

The committee also discussed this award should be eligible to undergraduate researchers. Shannon read the current language in the application and undergraduates are included.

We discussed this year's professional development format and everyone seem to like it. It was suggested that we use some of the "innovative ideas" to help facilitate this type of Professional Development in the future or at least model others strategies instead of repeating the same strategy.

We recommend for next year's Professional Focus on teaching since this year focused on research.

We elected two new members to the committee with a term expiring in 2021. These new members are Anna Warner from Washington State University and Sarah Bush from University of Idaho.
